M. A. Mortenson Company will be the CM/GC of a renovation project for the University of Utah at the South Jordan Health Center.

## **Project Description**

The project scope includes the renovation of 2,000 SF of existing radiology reception/waiting areas, changing rooms, and MRI support areas at the South Jordan Health Center to accommodate a second, new MRI room. The scope is anticipated to include the replacement of a portion of the existing slab on grade, evaluation of modifications to the existing fill, interior construction, MEP, shielding and low voltage, including access control and patient monitoring. Adherence to all infection control risk mitigation plans is required. Subcontractors understand the need for flexibility around operational needs of adjacent clinical spaces, including a willingness to perform work during off-peak hours.
